

SHEPPARTON AGRICULTURAL SOCIETY INC.

Contract for License to Occupy Ground Space.

It is hereby agreed (subject to the Rules and Regulations of the Shepparton Agricultural Society) hereinafter referred to as the Society, and to the conditions hereunder that. (Company name)

Hereinafter referred to as the Stand holder be licensed to occupy ground space with.....frontage by.....depth

Inclusive of guy-ropes and pegs for the purpose of.....

(But not otherwise) and situated on the Shepparton Show Ground for the duration of the Shepparton Show from 10am-10pm

to be held on Friday 13th & Saturday 14th October 2023 and that the Stand holder will pay the sum of \$_____ therefore.

CONDITIONS

1. Full amount of the abovementioned sum must be paid to the Secretary of the Society or other officer appointed immediately upon signing this contract. Site fee includes three Exhibitor Wristbands that cover both days of the show. Additional Exhibitor Passes may be purchased for \$10.00ea. People without exhibitor passes will have to pay the appropriate show entry fee, no refunds will be given. No refunds or credit on site fee if you cancel your booking after the Friday 29th September 2023.
2. The Stand holder shall not go into possession of space allotted until the day before the Show unless authorised in writing by the Secretary of the Society but must be in space by 10am Friday of show.
3. The Stand holder and / or his employees shall conduct themselves in an orderly and respectful manner while on the Show Ground and shall keep the space allotted in a clean and tidy condition.
4. The Stand holder shall accept the space allotted by the Society and use the same for the purposes aforesaid and for no other purpose.
5. No projections of any kind shall be permitted beyond the allotted boundaries of the Stand holder's site. In the event of any breach of this condition, the Society (through its officers) shall have the power to remove any such projections.
6. The use of amplifiers or loud- speakers may be permitted but if the use of these is in the opinion of the Chief Side-Show Steward such as to cause a nuisance, then the Stand holder must refrain from using such amplifiers or loud-speakers.
7. Selling goods, canvassing, or hawking in any portion of the Show Ground (not within the areas specified) is prohibited.
8. Except with the written consent previously obtained of the Secretary of the Society the Stand holder shall not assign or sub-let or part with the possession of the whole or any part of the space hereby licensed to be occupied or purport so to do.
9. All stock or stands must be removed from the Show Ground within two days after the termination of the Show.
10. The Society shall not be held liable for loss of or damage to the Stand holder's property whilst on the Show Ground.
11. If the Society should find it necessary to expedient to cancel or postpone the Annual Show this contract shall cease to operate upon notice to that effect signed by the Secretary being served on the Stand holder by handing it to him personally or by posting it to him at his address appearing in the records at the Society or by handing it to any person who appears or is thought by an officer of the Society to be an employee, agent or partner of the Stand holder and the Society shall not be liable to the Stand holder for any compensation whether on the ground of loss of profits or otherwise in respect of such cancellation or at all.
12. The Secretary, Executive Officers or Side-Show Stewards shall at all times, have the right to enter on the licensed area and remove any article, sign picture or printed matter which in their opinion may be a cause of offence to the public or officials of the Society.
13. The Society reserves the right to cancel this contract, to retain all money paid in connection therewith and to remove the Stand holder and his stand from the show ground if there is in the opinion of the Secretary any infringement of the conditions of the contract and the Society shall not be liable to pay the Stand holder any compensation whether on the ground of loss of profits or otherwise in respect of such cancellation.
14. The Society shall not be liable to the Stand holder for loss of profits or otherwise if as a result direct or indirect of any cause beyond the reasonable control of the Society including complete or partial failure in or suspension of the supply of gas, water or electric current, storm-water or sewerage services to the Show Ground or any part thereof the Stand holder is prevented or impeded in using the space to be occupied as originally contemplated.
15. The Stand holder shall connect at its/his own expense any electrical, gas or water connections from the nearest point at which the service is made available by the Society. Such connections must conform to the regulations of the relevant authorities. The Chief Side Show Steward shall have the right to disconnect any electrical apparatus that he may deem unsafe or may be overloading service lines feeding the said apparatus.
16. The Stand holder accepts all responsibility for any damage or injury of any description which may be occasioned by or arise out of the use of any machinery, implement or apparatus of any nature whatsoever used in connection with the space allotted to the exhibitor or which may occur directly or indirectly (whether through negligence on the part of the Stand holder or whosoever otherwise) in through or from the carrying on of the Stand holders business or activity on the said space allotted and the Stand holder shall keep the Society indemnified against any claim(s) arising there from.

17. The Stand holder shall ensure that his stand is covered by insurance for public risk for an amount of not less than 10 million dollars and shall prior to occupation of the space allotted produce to the Society satisfactory proof of the currency of such insurance i.e. Certificate of Currency or Policy.
18. The Stand holder shall take all such steps as shall be necessary to comply with the provisions of the Workers' Compensation Act and all regulations and rules made there under and shall as and when required by the Society produce to the Secretary, Executive Officers, or Side Show Stewards satisfactory proof of his compliance therewith.
19. It is the Site-holder's responsibility to ensure they are compliant with the laws in regard to the sale of Novelty Items, including the Dangerous Goods (Explosives) Regulations 2000, Regulation 803, and the Dangerous Goods Act 1985 – 554, that an illegal item is not sold at the Show. Banned or illegal items will be confiscated. Consumer Business Affairs Victoria has the right to inspect any site at any time.
20. All site holder applications will be considered by the committee, who have the right to refuse any applicant they deem unsuitable.
21. All site-holders must comply with COVID conditions and restrictions including social distancing, hygiene practices, supply PPE as required in line with current Government advice.
